A drug testing fee of three dollars per horse will be charged for all horse shows offering prize money or accumulative points, and all the horse shows or two (2) or more days duration. A single-day horse show where the maximum entry fee is \$4.99 or less per class for the entire show and there is no prize money awarded is exempt from the testing and fee. |
